PROJECT SCOPE:

The Fire Station Weir Bank Protection Maintenance and Repair Project is located in the Las Vegas Wash, Clark County, Nevada.

The proposed Work is generally described as follows:

The Project comprises clearing, site preparation, excavation, dewatering and construction of a riprap bank protection on the Las Vegas Wash.

The Work is a public works project as defined by Chapter 338 of the Nevada Revised Statutes (NRS) and all Bidders are required to comply with, and the Contract shall be awarded and administered in accordance with, the laws contained in that chapter.

Instead of a delivery charge, mailing may be expedited by providing with the payment, the express mail carrier with account number to be charged. If mailing of the Bidding Documents via United Parcel ground is desired, an additional charge of \$20.00 is required.
