PROJECT SCOPE:

The project is located in Clark County, Nevada at various locations throughout the Las Vegas Valley.

The proposed Work is generally described as follows:

The Project comprises the plugging and abandonment of domestic and quasi-municipal wells in the Las Vegas Valley (Hydrographic Basin No. 212). Approximately fifty (50) wells are to be abandoned by state approved methods. Well sites will be made available to the CONTRACTOR as they are made available to the AUTHORITY throughout the term of this Contract.

The Work is a public works project as defined by Chapter 338 of the Nevada Revised Statutes (NRS) and all Bidders are required to comply with, and the Contract shall be awarded and administered in accordance with, the laws contained in that chapter.
